

## Teen—Parent Driving Agreement

**This agreement between parents and teenagers grants teenagers the right to drive.**

I, \_\_\_\_\_, do hereby agree with my parents that if they permit me to drive an automobile that is registered in their name I promise:

1. I will drive carefully, cautiously, in control and obey all traffic laws.
2. I will not allow our car to be driven by anyone other than another family member.
3. I will not allow our car to be driven by anyone who has been drinking any form of intoxicating liquor or has taken any type of illegal drug or any drug that could cause danger to passengers in the car or to the public.
4. I will not drive in excess of the posted speed limits.
5. I will not use my cell phone while driving.
6. I will not text on my cell phone while driving.
7. I will not go "cruising" with a carload of friends.
8. Even if I have the right of way, I will slow down and look both ways at all intersections.
9. I will not speed up to go through yellow traffic lights.
10. I will yield to other cars when entering a highway.
11. I will not race against other cars, no matter how tempting it may be.
12. I will not drive if I feel sleepy or ill, unless it is a true emergency.
13. I will obey all traffic signs, street and highway markings, signal lights and other regulations.
14. I will always wear my seatbelt and will not drive if any passenger refuses to wear one.

Furthermore:

1. I understand that as far as the law is concerned, my acts are the acts of my parents.
2. I fully realize that a car is not a plaything, but a powerful machine that has the power to kill and injure. I will treat it with respect and not show off with it.
3. I promise to pay any traffic fines and agree to just punishment.
4. I will relinquish my driver's license for 6 months if I receive 2 moving violations within the first year of my license.
5. I will pay for any insurance increases because of my driving record.
6. Each time I drive I will tell my parent where I am going, with whom and when I will return.
7. I understand that statistics for death and injury are the greatest during the first year of driving. I will not be a statistic!

I understand though this agreement is not legally binding, I give my parents my word of honor that I will do what I have promised above in consideration of their permission to drive a family car. My parents, at their discretion, may revoke my privilege to drive a family car if I violate any of these agreements.
